Year End Awards for Training through FEI Levels

Prizes are awarded to the Tehachapi Mountain Chapter members achieving the highest overall average scores across at least three shows. This will be based on the highest score at each show. Scores may be earned at any test in the level. Rides must be on the same horse. Winning average must be 60% or greater. Each winning rider also receives a Certificate of Achievement.

Year End Awards for USDF Introductory Classes

Certificates of Achievement are awarded to the Tehachapi Mountain Chapter members achieving the highest overall average scores across at least three shows. This will be based on the highest score at each show. Scores may be earned at any test in the level. Rides must be on the same horse. Winning average must be 60% or greater. The winning rider from the Open, Adult Amateur, and Junior Divisions will be awarded a Certificate of Achievement.

Tehachapi Mountain Chapter Junior High Point Perpetual Trophy

Awarded to the Tehachapi Mountain Chapter Junior rider achieving the highest overall average scores across at least three shows. This will be based on the highest score at each show. Scores may be earned at any test in the level. Rides must be on the same horse. Winning average must be 60% or greater.

Year End Awards for Western Dressage Exhibition Classes

Riders are grouped by Division - Open, Adult Amateurs, and Juniors. Prizes to be determined, depending on the level of participation.

RULES, REGULATIONS, AND GENERAL INFORMATION FOR ALL TMC SHOWS

CONDITIONS OF ENTRY

1. "**The Mountain Solstice Dressage Show**" is covered by the rules and specifications of the current USEF Rule Book and will be conducted and judged in accordance therewith.
2. Every horse and pony entered for competition will be under the control of the Horse Show Management, but the Horse Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its Directors and Employees, the **Bear Valley Springs Equestrian Center**, and its Directors and Employees, harmless for any loss or accident to his/her horse, horses, or equipment which may occur from accident, sickness, fire, or otherwise.
3. Horse Show Management reserves the right to arrange for additional judges and to cancel, combine, or amend any class, including but not limited to class awards, scheduling, and location. The Horse Show Management reserves to itself the right to refuse, accept conditionally, to cancel entries, or disqualify riders without claim to damages.
4. Horse Show Management reserves the right to interpret all questions and conditions in regard to or arising out of or incident to the show without claims for damages or recourse of any kind. All questions not covered by these rules and regulations shall be decided by the Horse Show Management and such determination shall be final.
5. All Owners and Exhibitors will be held responsible for any damage incurred by them, their agents, employees, or animals to stalls, buildings, and other properties on the show grounds and shall be billed accordingly. Competitors are responsible for all insurance for themselves, employees, owners, horses, etc. Competitors are personally responsible for damages to third parties caused by themselves, their employees, agents, or horses.
6. Parents or guardians of Minor Exhibitors shall hold the **Bear Valley Springs Equestrian Center** harmless for injury to such minor. No Child's entry blank shall be accepted unless it is signed by a parent or guardian. The signature of instructors, agents, or other unrelated persons will not be accepted.
7. Current USDF, USEF, and FEI tests will be used for English Dressage. For Western Dressage tests, the current WDAA tests will be used. All tests will be ridden in a 20 x 60 meter arena.
8. Western Dressage Classes: Horses and riders competing in "Western Dressage" classes ONLY are exempt from CDS membership requirements, and do not have to pay CDS non-member fees. Horses entered only in "Western Dressage" are still subject to and must comply with all Drugs & Medication rules and are subject to testing at this competition. Horses/riders will be allowed to cross-enter into other recognized classes at this show. However, please note, if a horse or rider enters other non-western dressage classes at this competition in which membership by participants is required, all CDS membership requirements apply for horse, rider, owner, trainer, etc. If entering both traditional and "Western Dressage" classes, use a separate entry form for each discipline. Riders who enter in both traditional and "Western Dressage" classes need only pay the CDEFA Drug, Grounds, and Office fees on the first entry form. Scores earned in "Western Dressage" classes DO NOT COUNT towards CDS awards.

9. Non-competing Horses: Each Non-competing Horse must wear an assigned number and must observe the rules governing the use of the warm-up areas and the show. There is a Non-competing Horse fee of \$25 as well as the Office and Grounds fees. Any horse brought onto the grounds, including the parking lot, is subject to the rules of the show and must be available for drug testing if selected. Any person riding a Non-competing horse must have a signed and official entry form and/or release.

10. CDS Pony Award: The high scoring pony at Training through Grand Prix (Freestyles excluded) at each CDS recognized show will receive a High Score Pony Ribbon. The CDS Central Office will send out the award to the pony rider. All pony riders should inform show management that they would like to be considered for the CDS Pony Award. CDS will also offer a Year End Award to the Highest Scoring Pony in Open, Amateur, and Junior Divisions. To be eligible, all ponies **must** have a current USEF DRESSAGE Pony Measurement Card.

ENTRIES – RIDE TIMES

11. Entries will be accepted on a first-come basis and must include all fees, membership and horse registration proofs, Entry Agreement signatures, and payment. Numbers will not be released until this process is complete; entries without payment in full may be returned. Entries that are received complete with payment, signatures, and proofs will have priority over late entries. If the show has extended the courtesy of accepting a late entry, the responsible party will be liable to pay all class, stabling, and other fees.

12. Copies of all membership cards are required. To enter the English Adult Amateur division, the USEF membership card **MUST** indicate Amateur status and the individual must have reached the age of 22 in the current year. If you do not submit proof of Adult Amateur status, you will be entered in the Open division. JR/YR classes are open to riders under 21 years of age as of the previous year. Open classes are open to all.

13. Fees: Class fees for Open and Adult Amateurs are \$40 per class, Class fees for Juniors and Young Riders are \$30 per class, CDFA Drug Fee is \$8.00, CDS Travel Grant Fee is \$3.00, CDS Non-member fee for riders is \$15, CDS Non-member fee for owners is \$15, Office Fee is \$30, Grounds Fee is \$10, the Non-competing Horse fee is \$25, and the Late Fee is \$20 per entry.

14. For all shows at the Bear Valley Springs Equestrian Center, residents of Bear Valley Springs may haul-in for schooling on Saturday and show on Sunday without paying the Grounds fee. Horses permanently stabled at the Bear Valley Springs Equestrian Center are exempt from the Grounds fee when showing at the Bear Valley Springs Equestrian Center. Non-residents who wish to school their horses at the Bear Valley Springs Equestrian Center on Saturday must be sponsored by a Bear Valley Springs resident and will need to pay the Grounds fee directly to the Bear Valley Springs Equestrian Center. This fee applies to any horse brought onto the grounds, even if the horse remains near the horse trailer or is ridden or led onto the grounds.

15. Late Entries: The closing date for all TMC shows will be two weeks prior to the day of the show. All entries must be **POSTMARKED** on or before the closing date or will be considered a late entry. Each late entry will be charged a late fee of \$20.

16. Scratches: Exhibitors have the responsibility of informing the Show Office of their intention to scratch. No refunds will be issued for scratches made after the closing date. No-Shows will be billed for any outstanding fees. Scratches after the closing date **with a vet note** will receive a full refund. To scratch, email helluvastorm0815@gmail.com. An intention to scratch must be in writing.

17. Checks returned by the bank will be assessed \$25 or the bank fee (whichever is higher) upon the first return and will not be run a second time. A Cashier's Check or cash will be needed to clear the entry.

18. Classes will be scheduled to accommodate the judge, riders, and management. Rider scheduling preferences, if noted on the entry form, will be indulged when possible. The 50 minutes between rides rule will be observed for riders of multiple horses. Requests for specific break parameters and/or ride times will be considered, but not guaranteed. Classes will not necessarily be scheduled in order of difficulty.

19. Provisional ride times will be emailed to everyone who supplies an email address and will be available for download at www.tmcdressage.org. It is the responsibility of the rider to inform management of any time conflicts at least 24 hours before the scheduled rides.

20. It is the purpose of the management to run the Horse Show at the highest possible level of Sportsmanship. Management has used the utmost care to select judges with broad experience and knowledge. The judge's decisions in the show ring are their own responsibility and management accepts no responsibility for those decisions. Every class offered here-in which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith.

STABLING – GROUNDS

21. ABSOLUTELY NO DOGS ALLOWED ON THE SHOW GROUNDS.

22. Stabling: Stabling at the Bear Valley Springs Equestrian Center is based on limited availability/first come-first serve. Participants agree that show management is merely providing stabling for the convenience of the participant and the management and sponsoring organizations shall have no responsibility whatsoever for any injury, loss, damage, etc. as a result of using said stabling. Owner/Agent/Participant assumes all care, custody, and control with regard to this use. To arrange stabling, contact Butch Bolterman, Equestrian Center Manager at 661-821-3960 or butchb@bvsa.org. Fees for stabling will be paid directly to the Equestrian Center. For all competitors stabling or camping, Sunday's Grounds fee must be included with the competitor's show entry.

23. Please park in the large area below the warm up arena. Non-residents of Bear Valley Springs are not permitted to ride the trails or utilize any of the other arenas except for the designated warm up ring and the show arena.

24. Sand or dirt is used in the 20x60M competition and warm-up arenas. Only horses entered in the show are permitted to use the warm-up arenas and the competition arena. No one on foot will be permitted in the warm-up arenas. Lunging is to be done in the designated area ONLY. All arenas must be vacated when equipment is in use. Use of the warm-up arena is limited to those who are entered in the show and, at the discretion of the Show Management, will be restricted to those warming up for class(es) in progress when there is congestion. Residents of Bear Valley Springs will be permitted to utilize the warm up arena during the show. While it is uncommon for them to do so, please be courteous.

25. Bridle numbers must be worn at all times when the horse is out of the stall or away from the trailer.

26. Please do not tie horses to any fences or gates. Use hitching rails and cross ties only. For bathing horses, please use the designated wash racks located in the campground near the restroom. Do not use the wash racks near the main barn as those are reserved for Bear Valley Springs Equestrian Center boarders only.

MISCELLANEOUS

27. Sharps Containers: Competition management is responsible for placing Sharps containers in convenient locations on Competition grounds and replacing them when full. Competition Management may fine any individual up to \$100 for improper disposal of needles or other sharp disposable instruments. See GR1210.4 for complete details.

28. Ribbons and Awards: English Dressage Classes - Ribbons are awarded for First through Third. Riders are grouped by division: Open, Adult Amateur, and JR. Show High Point Prizes (Training through FEI Levels) with scores of 60% or greater will be awarded in each division.

29. Freestyles: Effective 12/1/18, Per USEF Rule DR129.9: "Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior, FEI Young Rider and FEI Para-Equestrian Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% in the highest test of the declared freestyle level or any test of a higher level at a Federation Licensed or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. BOD 8/27/18 Effective 12/1/18" If you have questions about this rule, please contact Hannah Niebielski at USEF.

30. Cancellation: In the event of rain prior to the show, show management will endeavor to email competitors as well as place a notice on www.tmcdressage.org. It is the competitor's responsibility to call the show management to determine whether the show is cancelled. If the show is cancelled for any reason, the \$30 office fee will be retained to cover expenses incurred from hiring the judge.

31. All entrants in shows at the Bear Valley Springs Equestrian Center must have a new, signed Liability Release form on file each year. No show numbers will be provided until the form is submitted. Riders may fill out the form upon arrival at the Equestrian Center, or, to save time, print out the form, sign both sides and either send it with a mailed entry, or bring it to the show. 32. Non-residents of Bear Valley Springs (BVS) must obtain a gate pass before being allowed entry into BVS. Non-resident competitors will automatically have a gate pass assigned to them. Please notify Show Management if additional gate passes are required for spectators or guests of competitors. No unauthorized vehicles will be permitted to enter BVS without a gate pass.

ENTRY AGREEMENT (release)

By entering this Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Rules of the United States Equestrian Federation (USEF), the California Dressage Society (CDS), and the local rules of **The Mountain Solstice Dressage Show** (Competition). I agree to release and hold harmless the competition, CDS, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered.

I also agree that as a condition of and in consideration of acceptance of entry, USEF and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or USEF. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

Release, Assumption of Risk, Waiver, and Indemnification
This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition, **The Mountain Solstice Dressage Show**, to the following:

I AGREE that CDS and the "Competition" as used herein includes the Licensee and Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, volunteers and Federation affiliates.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaultor, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. ("Harm").

I AGREE to hold harmless and release the USEF, CDS, and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Federation or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I have read the Federation Rules about protective equipment, including GR801 and, if applicable, EV114, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I AGREE that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form.

BY SIGNING BELOW, I AGREE to be bound by all applicable Federation Rules and all terms and provisions of this entry blank and all terms and provisions of this Prize List. If I am signing and submitting this Agreement electronically, I acknowledge that my electronic signature shall have the same validity, force and effect as if I affixed my signature by my own hand.
